**NOTICE IS HEREBY GIVEN**, the following Resolution were adopted at a Regular Meeting of the Mayor and Council of the Borough of Allendale on Thursday, September 24, 2026:

### **AWARDING A CONTRACT FOR THE PAVING PROGRAM 2026 RESOLUTION #26-224**

**WHEREAS**, the Borough of Allendale authorized the advertisement and receipt of sealed bids for the Paving Program (2026), VCEA Project No. ALN-1003.013, in accordance with the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq.; and

**WHEREAS**, the project generally includes work-zone traffic controls, hot-mix asphalt milling, surface and base courses, resetting castings, curb work, drainage-structure cleaning, pavement markings, and related work as set forth in the Contract Documents prepared by Van Cleef Engineering Associates, LLC; and

**WHEREAS**, the Borough advertised the project on September 2, 2026, and received and publicly opened eight (8) sealed bids on September 17, 2026, at 10:00 a.m.; and

**WHEREAS**, Van Cleef Engineering Associates, LLC reviewed the bids and, by correspondence dated September 22, 2026, recommended that the contract be awarded to **D & L Paving Contractors, Inc.**, of **675 Franklin Ave., Nutley, New Jersey 07110**, as the lowest responsible and responsive bidder, based upon its Total Bid Amount of **\$120,224.50**; and

**WHEREAS**, the award is subject to the approval of the New Jersey Department of Transportation, the certification of available funds by the Chief Financial Officer, review and approval by the Borough Attorney, and the successful bidder's submission of all required bonds, insurance, registrations, certifications, and other contract documents.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Borough of Allendale, County of Bergen, State of New Jersey, the contract for the Paving Program (2026) is hereby awarded to **D & L Paving Contractors, Inc.**, of **675 Franklin Ave., Nutley, New Jersey 07110**, as the lowest responsible and responsive bidder, based upon its Total Bid Amount of **\$120,224.50**, based upon the unit prices and estimated quantities contained in its bid proposal.

This resolution shall take effect immediately.
